FC Lamoureux sent the final payment & retainage for the training center, so the department now owns it.

FC Lamoureux informed the board the tactical tender is also at station 40 and Acela will be here on Thursday and Friday for training and to drive it around the station.

The department only used 13% of the OT budget for Union Gap.

The department will be hiring summer help on June 1<sup>st</sup>, 2026. Applicants must have firefighter 1 and an EMT certification.

FC Lamoureux informed everyone that 6 contractors have reached out so far for the bid for the storage building behind station 40. There have been no submissions yet.

The spaghetti feed is coming up on the 25<sup>th</sup> of this month.


