The training tower is almost complete, FC Lamoureux is just waiting to see if a gas meter is found. FC Lamoureux is waiting for the HLA to get the site plan back for the storage building.

DC Munson informed the board that recruit class is going well and the testing scores are showing. Saturday will be the annual banquet but the department is still looking for a venue.


